Minutes of the Barrowby Burial Ground Committee Meeting held on Friday 14th January 2022 at the Reading Room, Barrowby at 1.00pm

Site Visit – 12.30pm

1. WELCOME REMARKS (22/019)

4. APPROVAL OF MINUTES (22/022)

4.1 The Clerk's minutes of the Burial Ground Committee meeting on 12th November 2021, having been proposed by Councillor Inglis and seconded by Councillor Townsend, were agreed to be a true and accurate record and were passed unanimously by the committee.

5. BURIAL GROUND UPDATE (22/023)

5.1 <u>Burial Ground Update</u>

There has been one burial and one interment of ashes in the Burial Ground since the previous meeting. In total 18 during the year, 10 burials and 8 interment of ashes.

5.2 <u>Ashes Plot Availability</u>

During the site visit it was agreed that an extra row of ashes plots will be put in C66-75. Also one extra plot at end of current row C56a.

Action: Assistant Clerk to update spreadsheet.

An application was considered from the widow of a gentleman resident in Grantham for the past 22 years. Although previously a resident for some time in Barrowby this application failed to meet the Burial Ground criteria as laid down in the policy. Considering this the committee agreed this application would be declined. The application for purchase and burial was received from Robert Holland Funeral Directors' therefore they are to be notified of the decision.

Action: Assistant Clerk to notify Robert Holland's of the decision.

5.3 <u>Burial Ground Maintenance</u>

Councillor Inglis has carried out the following work: salted paths, raked up leaves, removed growth from fence. Part of the fencing needs repairing. Dave Merchant to be asked to check all trees.

Action: Assistant Clerk to ask Mr Barker for two quotes for fencing one leaving one bar free. Also contact Dave Merchant to arrange checking of trees.

5.4 Burial Ground Policy & Memorial Bench Policy

It was agreed to recirculate the sample Memorial Bench Policy for review and to be updated at the next meeting.
