## Application to Erect, Replace, Repair or Amend a Memorial in Barrowby Burial Ground

This application is to be completed and **signed by the owner of the Grant of Exclusive Right of Burial and the Memorial Mason** for every kind of work proposed to be carried out in relation to a memorial at Barrowby Burial Ground. The approval of the Burial Authority is essential before the Memorial Mason is instructed, and once given, the Memorial Mason can carry out the authorised work, to either remove an existing memorial or install a new one on the date requested.

Please note that following an interment a memorial cannot be erected on a grave in less than six calendar months from the date of burial and, in the case of cremation, a memorial plaque cannot be laid in less than three calendar months after the interment of remains of the deceased.

I agree to allow Barrowby Parish Council to carry out random testing of memorials to National Association of Memorial Masons standards (or any other relevant Health and Safety standards pertinent at the time) to ensure that I am complying with my obligations as owner of the Grant of Exclusive Rights of Burial of the above grave/plot. If the memorial is found to be in an unsafe condition at any time, I accept that the memorial will be laid flat/removed and that I will be responsible for the cost of removal and renovation/repair cost if I choose to have the memorial reinstated. I will ensure that I notify the Clerk to the Parish Council, in writing, of any change of address to enable him/her to notify me of any changes in the rules or regulations that may affect the grave or memorial. I will request an appointment at the time to erect the memorial giving at least twenty-four hours' notice.
- I understand that a representative of Barrowby Burial Authority may verify that BS8415 has been adhered to during the completion of the work being undertaken.
- ➤ I have explained to the owner of the Exclusive Right of Burial that the memorial remains their property and that they are responsible for always keeping it in good and safe condition to current industry and general Health and Safety standards.
- I have advised the owner to consider the benefit of insuring the memorial against accidental damage and vandalism.
